WHEREAS, Socialism advocates community control and Communism advocates governmental control of that which the individual controls in a free society;

AND WHEREAS, the Principles of the Platform of the Republican Party of Arkansas include the following:

AND WHEREAS, the Platform of the Republican Party of Arkansas states:

We are created equally with Individual freedoms and liberties.

Our self-evident rights must always continue to be secured at the individual, state, national, and international levels.

We, the Republican Party of Arkansas, believe the United States Constitution is the fundamental framework for our federal government and is a literal document that is as relevant today as it was when our nation's Founders adopted it. We support its precepts and, as patriots, vow to defend the rights of our fellow Arkansans guaranteed by the Bill of Rights generally, and the Ninth and Tenth Amendments specifically.

We strongly believe in the equal and just enforcement of the law, especially as it pertains to an overreaching government threatening...inherent freedoms.

AND WHEREAS, we SUPPORT the Arkansas 93rd General Assembly enacting 2021 Act 1002 Ending of Mandatory Face Covering Requirements;

AND WHEREAS, we SUPPORT the Arkansas 93rd General Assembly enacting 2021 Act 1030 No Vaccine Mandates;

AND WHEREAS, we SUPPORT the Arkansas 93rd General Assembly enacting 2021 Act 1100 Prohibiting Propagation of Divisive Concepts such as Critical Race Theory;

BE IT RESOLVED, we OPPOSE the teaching of Socialist, Marxist and Communist ideologies to our children including the teaching of Critical Race Theory;

BE IT FURTHER RESOLVED, we OPPOSE the Socialist ideology that our children belong to the community as well as OPPOSE the Communist ideology that our children belong to the government;

BE IT FURTHER RESOLVED, we SUPPORT the individual freedoms of Arkansas parents to make all decisions effecting the care of, the well being of and the best interests of their own children, including but not limited to educational decisions, philosophical decisions, religious decisions and medical decisions such as whether to mask and vaccinate;

BE IT FURTHER RESOLVED, we OPPOSE judicial overreach and overreach of school boards and other government entities attempting to usurp the inherent freedoms of Arkansas parents to make decisions for their own children;

BE IT FURTHER RESOLVED, we OPPOSE legislation, school board decisions, judicial decisions including case law and other directives which infringe upon the fundamental individual rights of parents and children in the State of Arkansas as provided by God, the US Constitution, the Arkansas Constitution, Bill of Rights and Federal and State Statutes.
